CMS 2025 Patient Safety Measures

CMS is introducing pay-for-performance reporting measures assessing how hospitals plan and implement safety improvement initiatives. Starting in 2025, hospitals will report on five new Patient Safety Structural Measure (PSSM) domains. Below, we break down the reporting categories and how Caregility can help you meet key attestation requirements.

- Leadership commitment to eliminating preventable harm
 Patient safety should be central to all strategic, financial, and operational decisions.
 - Capture patient safety metrics to inform performance reviews and compensation
 - Assess and share system-wide insight into patient safety initiatives and metrics
 - Equip staff with patient safety tools (i.e., virtual observation for fall prevention, etc.)
- Strategic planning and organizational policy

Use of written policies and protocol that demonstrate patient safety is a priority.

Provide infrastructure to foster and prioritize safety awareness and education.

Transparency around safety events to support accountability for outcomes.

- Secure reporting of patient safety events, interventions, prompts, etc.
- Patient safety metrics are tracked and made public in hospital units
- Patient and family engagement

Involve families and caregivers in patient care planning to enhance outcomes.

• Support family presence as essential care team members in rounding and discharge planning, with 24/7 visitation as feasible
